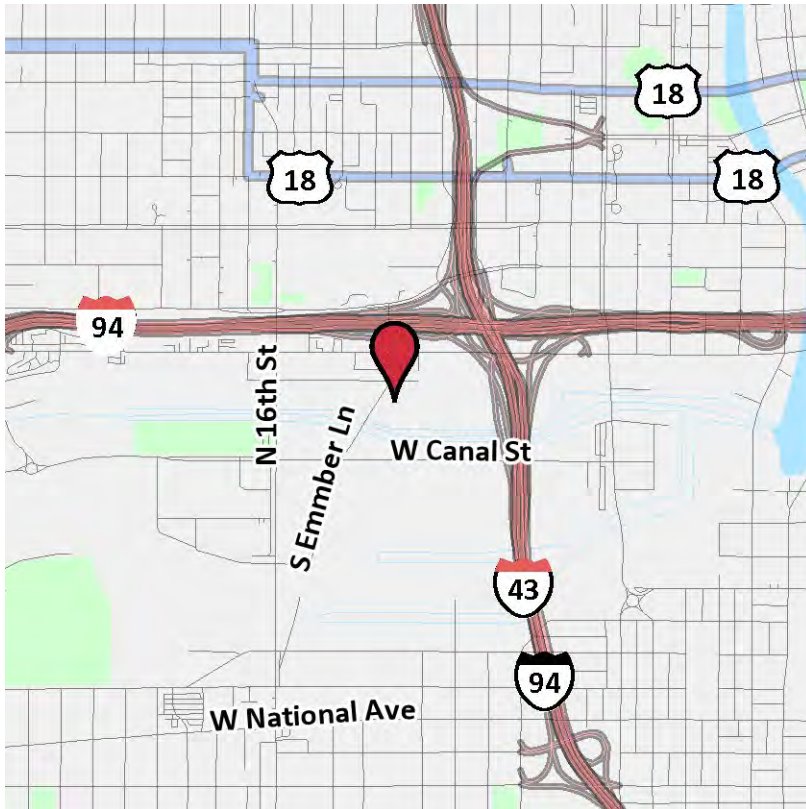

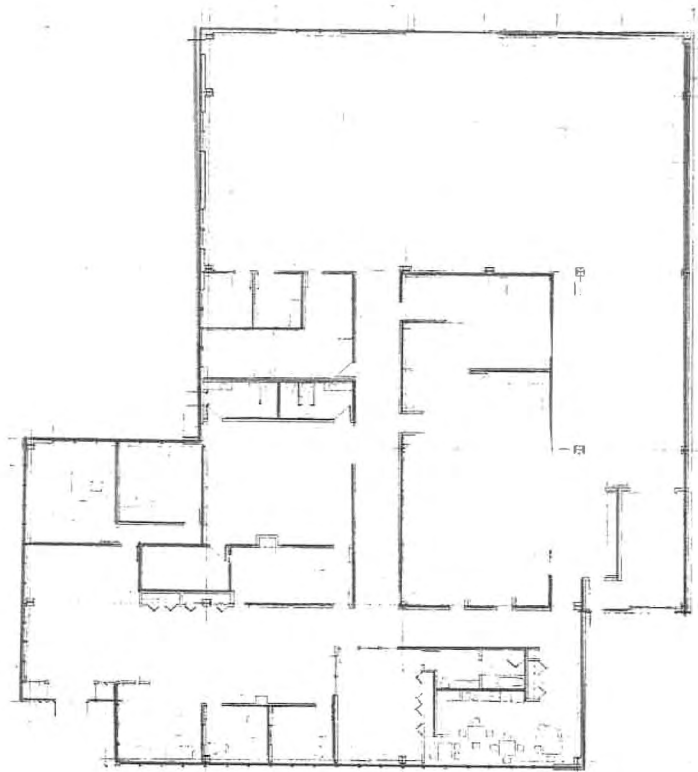

Floor Plan



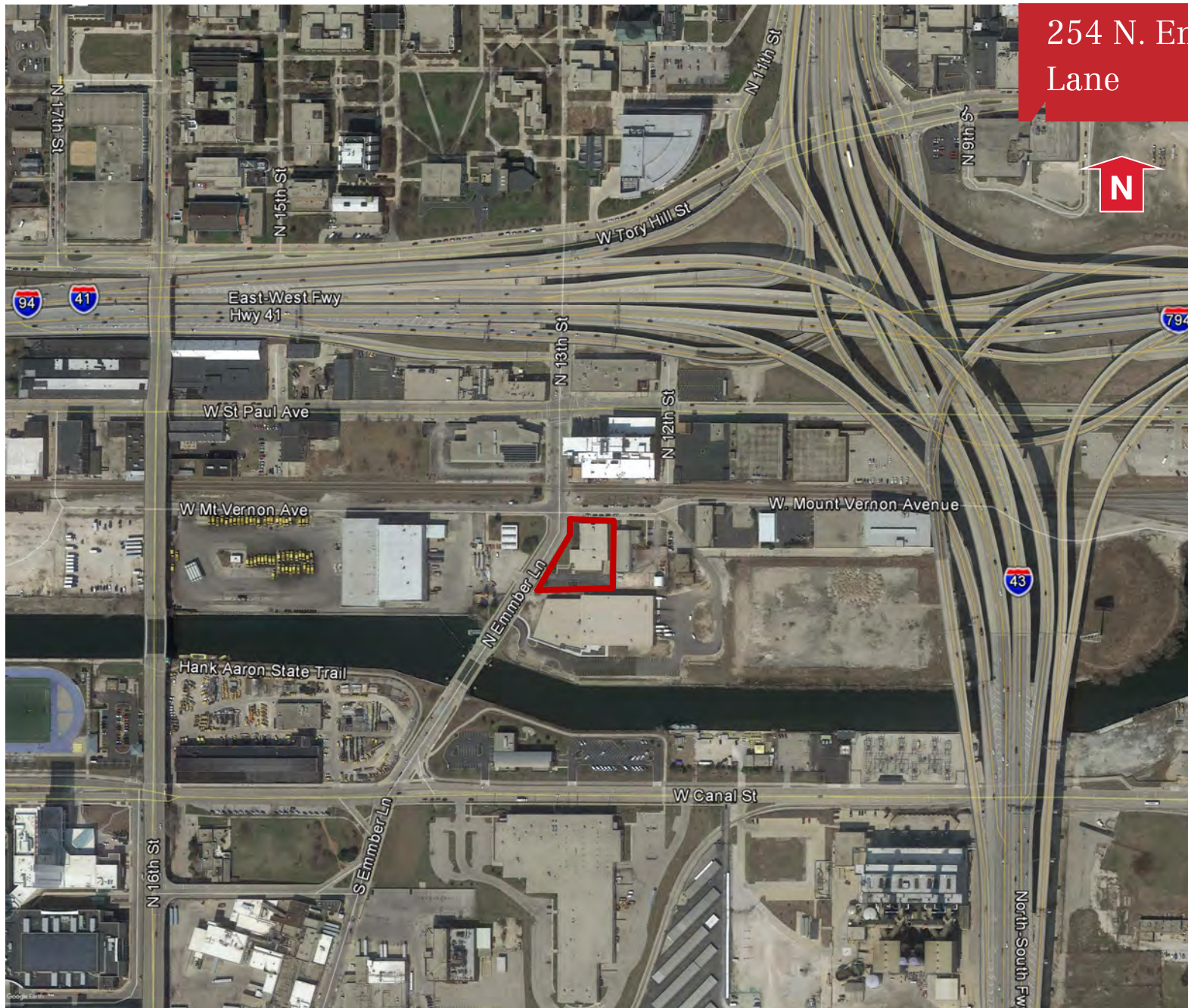

State of Wisconsin Broker Disclosure to Non-Residential Customers

DEFINITION OF MATERIAL ADVERSE FACTS
